**I. CALL MEETING TO ORDER**

**Mayor Popp called the meeting to order at 7:00 p.m. and presided. There were 15 electors present.**

**City Clerk Debra Patrick read the call of the meeting and the warning to electors.**

All persons legally qualified to vote in meetings of the City of Groton are hereby notified and warned to assemble in public meeting at the Council Chambers in the Municipal Building, 295 Meridian Street, Groton, Connecticut on Monday, January 5, 2009 at 7:00 o'clock p.m. prevailing time, for the purpose of acting upon the following matter:

Mayor Popp read the resolution title.

**“RESOLUTION THAT THE MAYOR AND COUNCIL APPROVE AN ORDINANCE AUTHORIZING THE PURCHASE OF TWO PARCELS OF REAL ESTATE FROM THE TOWN OF GROTON, NAMELY, A PARCEL ON NORTH ROAD AND A PARCEL ON BUDDINGTON/OLD BUDDINGTON ROADS, FOR A TOTAL COST NOT TO EXCEED TWENTY-FIVE THOUSAND DOLLARS AND NO CENTS (\$25,000.00) TO BE PAID FROM THE 1995 WATER DIVISION BOND FUND PROGRAM”**

1. To receive a communication from the Mayor and Council with respect to a proposed resolution entitled “An Ordinance authorizing the purchase of two parcels of real estate from the Town of Groton, namely, a parcel on North Road and a parcel on Buddington/Old Buddington Roads, for a total cost not to exceed twenty-five thousand dollars and no cents (\$25,000.00) to be paid from the 1995 Water Division Bond Fund Program”.
2. To consider and act upon a resolution entitled “An Ordinance authorizing the purchase of two parcels of real estate from the Town of Groton, namely, a parcel on North Road and a parcel on Buddington/Old Buddington Roads, for a total cost not to exceed twenty-five thousand dollars and no cents (\$25,000.00) to be paid from the 1995 Water Division Bond Fund Program”.
3. To take action on any other business which may legally come before said meeting.

**THEREFORE, BE IT RESOLVED** that the electors and qualified citizens of the City of Groton approve the subject resolution.

Mayor Popp asked for a motion.

**Michael Street, 16 Church Street** moved **Paul Duarte, 54 Cottage Street** seconded the motion to approve.

Mayor Popp said this land purchase has been in the works since 1995. He asked if there was any further discussion.

**R-09-1-1 RESOLUTION THAT THE MAYOR AND COUNCIL APPROVE “AN ORDINANCE AUTHORIZING THE PURCHASE OF TWO PARCELS OF REAL ESTATE FROM THE TOWN OF GROTON, NAMELY, A PARCEL ON NORTH ROAD AND A PARCEL ON BUDDINGTON/OLD BUDDINGTON ROADS, FOR A TOTAL COST NOT TO EXCEED TWENTY-FIVE THOUSAND DOLLARS AND NO CENTS (\$25,000.00) TO BE PAID FROM THE 1995 WATER DIVISION BOND FUND PROGRAM”**

**WHEREAS**, as part of the approved 1992 Water Division Bond Fund Program, the Land Purchase – Buddington Road was included as a project line item in the amount of \$34,000 for the proposed purchase of an approximately two-acre parcel located on the easterly side of Buddington Road that would offer continued protection of the water supply in the Poquonnock Reservoir; and

**WHEREAS**, Management reported to the City of Groton Utility Commission at its meeting held on October 19, 1995 that the Town of Groton, in June of 1990, acquired through tax sales two parcels of land abutting the City's reservoirs; and

**WHEREAS**, Management expressed its desire to acquire the parcels, one of which was adjacent to the gravel mining area off Buddington Road formerly owned and mined by New London Sand and Gravel and the second parcel located off North Road near the area where Groton Utilities had experienced numerous vandalism attacks during the early summer months of 1995; and

**WHEREAS**, at its meeting held on October 19, 1995, the City of Groton Utility Commission unanimously approved the purchase of two parcels of land acquired by the Town of Groton through tax sales, namely, a parcel on North Road and a parcel on Buddington Road; and

**WHEREAS**, at its special meeting held on November 14, 1995, the City Council unanimously approved this purchase; and

**WHEREAS**, although the purchase of both parcels was approved and a check payable to the Town of Groton generated in 1995, the sale was not consummated and was later cancelled from the 1992 Water Division Bond Fund; and

**WHEREAS**, there are funds available in the 1995 Water Division Bond Fund Program for the acquisition of properties adjacent to existing reservoirs in the towns of Groton and Ledyard; and

**WHEREAS**, on several occasions, the City of Groton's Mayor Dennis L. Popp spoke with the Town Manager, Mayor and Council and learned the sale has been approved by the Town of Groton; and

**WHEREAS**, in anticipation of approval by the City of Groton Utility Commission, the proposed purchase of the two parcels of real estate was referred to the City of Groton Planning and Zoning Commission in accordance with Connecticut General Statutes § 8-24 for consideration and approved at its meeting held on November 18, 2008; and

**WHEREAS**, at its regular meeting held on November 19, 2008 the City of Groton Utility Commission approved the purchase of these two parcels of land from the Town of Groton to enhance the security and safety of Groton Utilities' reservoirs for a total cost not to exceed \$25,000 to be paid from funds available in the 1995 Water Division Bond Fund; and

**WHEREAS**, this Ordinance was published in The Day, a newspaper having general circulation in the City of Groton on December 4, 2008 and December 5, 2008;

**WHEREAS**, said parcels are more specifically described as follows:

The Town of Groton, with its principal place of business located at Town Hall, 45 Fort Hill Road, Groton, Connecticut 06340, a municipal corporation within the State of Connecticut, for consideration paid, grant to the City of Groton, with its principal place of business located at City Hall, 295 Meridian Street, Groton, Connecticut 06340, a municipal corporation in the Town of Groton, County of New London and State of Connecticut, with QUIT CLAIM COVENANTS,

Thence, running westerly by and along other land of this grantor 80 feet to a point;

Thence, running northerly by and along still other land of the grantor 50 feet to land belonging to the Borough of Groton;

Together with a right-of-way over and across Hanover Avenue being 50 feet wide to North Road;

**THEREFORE, BE IT RESOLVED** that the Mayor and Council approve "An Ordinance authorizing the purchase of two parcels of real estate from the Town of Groton, namely, a parcel on North Road and a parcel on Buddington/Old Buddington Roads, for a total cost not to exceed Twenty-Five Thousand Dollars and No Cents (\$25,000.00) to be paid from the 1995 Water Division Bond Fund Program.
